

Terms and Conditions

- 1. The exhibition location, dates and opening hours are indicated above. NTCE organizing committee reserves the right to make changes regarding the dates, times and location if deemed necessary. The exhibitor will be notified of such changes immediately.
- 2. Application for exhibition space must be made on the official application form as soon as possible at the latest by 5^{th} of September 2018.
- 3. The signed application form has to be sent to MEGAWORKS via email. The booking becomes binding once a confirmation of the exhibition stand has been sent to the exhibitor.
- 4. The exhibitor will be contacted by the supplier should they indicate a need for additional requirements that come at a fee. The supplier will invoice and deal directly with the exhibitions suppliers.
- 5. All cancellations must be made in writing and have to be confirmed by NTCE committee. All cancellations received before 14th September will be subject to a service charge of R4500.00 excl. vat.
- 6. Installation and dismantling of the booth/stand may only be allowed during the specified times above.
- 7. Technical and power services are exclusively provided by the event facility through MEGAWORKS.
- 8. No exhibiting company shall assign, sublet or apportion the whole or any part of the contracted stand/booth space allocated to them without the knowledge and written consent of NTCE Committee.
- 9. The exhibitor agrees to abide by all of NTCE's rules and regulations, including but not limited to, rules of the event/exhibition facility and fire and safety regulations. NTCE reserves the right to deny participation in its programs and activities to individuals and organizations that violate its rules or whose participation, in NTCE's sole discretion is deemed detrimental to the interests and purposes of NTCE.
- 10. Only TWO people per booth or stand are permitted to attend the event. The exhibitor must indicate the full name of the persons on the Application Form for Exhibitors. Once the application form is submitted to MEGAWORKS, the specified person will be registered for free admission to the event.











- 11. Exhibitors shall cover their property against damage and loss at their own expense. Exhibitor agrees to waive the right of subrogation by their insurance carriers to recover loss sustained under the respective insurance contracts for real and personal property.
- 12. Exhibitor agrees to indemnify and hold harmless NTCE, Sun City Resorts and their respective partners, sponsors, agents, servants, and employees from any loss, damage, liability, costs, attorney's fees, or other of whatsoever nature arising from exhibitor's participation in the event, including but not limited to claims due to the injury, damage or loss to exhibitor's displays, equipment and other property brought upon the premises of the exhibition facility, except for claims solely resulting from the gross negligence of MEGAWORKS and/or the exhibition facility.
- 13. Exhibitor accepts South Africa as the place of jurisdiction for any disputes that may arise out of this contract. South African law shall be applicable exclusively.
- 14. NTCE reserves the right to modify or supplement these terms and conditions if necessary to ensure the implementation and success of the exhibition.
